The show is open to the public Fri., Sept 25: 12pm-7pm, Sat, Sept 26: 10am-6pm & Sun, Sept 27: 10am-5pm.

PART THREE: EXHIBIT FEES Below are options and rates (Tables are 6'). Within "Booths" there is room for additional sales tables, which may be taken in by the exhibitor, or can be rented for \$45/table (6'/undraped). Grids are permitted as well (contact BBS to inquire about potential renting option, or you may bring your own). Within Table Displays there is no additional tables are permitted other than a 2x2 or smaller for non-display purposes such as a cash box, etc. 25% deposits minimum is due with contract. An additional 25% will be automatically charged on July 15th. On Aug 16, 2015, the show balance will be charged. Fees incurred by facility for cleaning/damage for/to your exhibit space or otherwise caused by exhibitor shall be paid directly by that exhibitor within 15 days of notification. Any credit card information on file may be used to collect such fess with an additional 5% processing fee applied. All fees are due and non-refundable as of Aug 1, 2015. Written cancellations will be honored no less than 120 days prior to the event with all fees previously paid/due per schedule being due and/or nonrefundable. In the occurrence of event cancellation, other than per war or terrorism (see below), paid ¬funds will be returned.
