Event Hours: June 13 (Fri) 11AM-6PM; June 14 (Sat) 10AM-6PM; June 15 (Sun) 11AM-5PM

Event Set-Up: Please pick up exhibitor packet at show registration desk BEFORE you set up.

June 12 (Thurs) 2PM-9PM* & June 13 (Fri) 8:00AM-10:59AM IMPORTANT: You MAY NOT set up prior to check-in/approval.

Setting up beyond your space/taking tables will result in \$250.00 fine per table/occurrence due immediately.

Event June 15 (Sun) 5PM-8PM You may <u>NOT</u> breakdown or pack in anyway prior to June 15th at 5PM. Noncompliance will result in a \$250.00 penalty which will be due within 30 days of notice and may

result in forfeiture of future booth location consideration and/or booth space at any/all future Best Bead Shows. Any deposits already received will be forfeited, and additional payments will be subject

to stated refund policy per that event AFTER the \$250.00 fee has been assessed.

Damages: While the facility may have services to empty wastebaskets, etc., you are ultimately responsible for

or \$75/each after deadline [TBA], (if available). No Spanning Boards in Table Display locations!

Taxes, Etc.: You are responsible for all of your sales taxes, licenses, and permits for the state, cities and/or

municipalities of MD. (MD state law prohibits wholesale transactions under \$200)
