If cancellation is received in writing 150 days or more prior to event start date, payments previously received in excess of the deposit and penalty fees will be refunded in full. No cancellations within 150 days of the event will be accepted, and the full balance, including fees, will remain due. ♦ All payment information provided may be used for all payments due, present, past and future, for all matters pertaining to Falcon Endeavors including, but not limited to, third-party debts such as those incurred from facilities and shipping companies/departments. ♦The signer, and company and employees represented by whom, do hereby agree to participate in this Best Bead Show, and to abide by all rules/regulations set forth by show management herein and on second page, of which I hereby acknowledge receipt and understanding, and do hereby release from all liability The Best Bead Show/Falcon Endeavors, Inc., and its employees and affiliates, for any/all losses/injuries sustained as a result of such participation. # THE BEST BEAD SHOW Jan 26-30, 2024

**Event Times:** All days start 10AM. End times: Jan 26<sup>th</sup> – 29<sup>th</sup>: 6:00PM; Jan 30<sup>th</sup>: 4:00PM

**Set-Up:** Jan 25<sup>th</sup> 11:00AM-8PM & Jan 26<sup>th</sup> 7:00AM-10:00AM

*Please pick up exhibitor packet at show BEFORE you set up...*

**IMPORTANT: You MAY NOT set up prior to check-in/approval.** The Fire Marshall has threatened fines & shut downs as it is a violation for anyone other than decorator/staff to be inside prior to their approval. Violators will be fined \$1000.00 and will also be responsible for any/all fines/suits incurred by the Best Bead Show as a result of their actions.

**Anyone setting up beyond their contracted space** will be fined \$500.00 plus all billing/charges incurred.

**Anyone who takes tables** that were not in their booth (i.e. stealing) will be **fined \$500.00 PER TABLE!** If payment is not immediately received, you will be removed from show without refund. (You are stealing from show and exhibitors who took the time to complete paperwork and pay for their extra tables. All exhibitors want management to take shoplifting seriously; this is no different.)

**Breakdown:** Jan 30<sup>th</sup>: 4PM-8PM and Jan 31<sup>st</sup>: 8am-2:00pm (tables must be cleared by 11am Jan 31<sup>st</sup>)\*

*\*This may change at discretion of facility. If so, it will be communicated as soon as possible*

*You may NOT breakdown or pack in anyway prior to Jan 30<sup>th</sup> at 4PM. Noncompliance will result in a \$500.00 penalty (per instance/day) which will be due within 30 days of notice and may result in forfeiture of future booth location consideration and/or booth space at any/all future Best Bead Shows. Any deposits already received will be forfeited, and additional payments will be subject to stated refund policy per that event AFTER the penalty fees have been assessed.*

**Conduct:** Events considered by show management to be in direct competition may not be promoted at this event. Any/all behavior that show management considers damaging to the show reputation is strictly prohibited & may result in show expulsion without refund. It will be at the management's discretion to either allow the exhibitor to pack at the end of that business day or to cover that exhibitor's booth during remaining show hours allowing exhibitor to reenter facility only at the conclusion of the event. Expelled exhibitors may NOT be on property at any time not permitted by show management—noncompliance may result in criminal trespass charges. Anyone allowing public access to facility through non access points will be charged a \$500 penalty without notice.

**Damages:** While the facility may have services to empty wastebaskets, etc., you are ultimately responsible for your location in that any cleaning fees incurred by show management due to excessive trash and/or damage in or around booth areas will be payable immediately by exhibitors who occupied said booths in addition to a \$500 fine. **EACH EXHIBITOR MUST HAVE THEIR SPACE SIGNED OFF BY SHOW MANAGEMENT BEFORE LEAVING.**

**Food:** Food and drinks will be for sale by pre-scheduled vendors.

**Shipping:** NOTHING can be shipped to the show location until Jan 25<sup>th</sup> BUT a Receiving Form must first be submitted. [Provided at later time with Receiving fee indicated. If we can have items shipped Jan 24<sup>th</sup> you will be notified as soon as possible.]

**Signs:** No exhibitor signs may protrude beyond or above booth without PRIOR show management approval. Flyers, postcards, promotional materials, etc. may not be displayed outside your booth area (inclusive of lobby, restrooms, concessions area, or any other location within the immediate control of the Best Bead Show) without PRIOR approval.

**Taxes/Scales:** If you use scales you must have them registered with the state. Call (602) 255-5211.

All exhibitors must get an Arizona Tax number. Call (602) 255-2060

**Sharing:** THERE IS NO SUBLETTING. Booths may be SHARED, but ONLY IF approved in advance. There must be signed contracts for all participants, with the main contact specified, who will be solely responsible for all payments and paperwork. Each exhibitor will receive their own sign. There is a \$25 surcharge per each additional vendor.

**There cannot be more than two (2) exhibitors per single/regular booth area and tables CANNOT be shared.**

**Parking:** **IMPORTANT!!!** During Open to Public show hours, exhibitors MUST park only in the designated exhibitor parking area. Taking parking spaces away from buyers is detrimental to the show in general and YOU! **FAILURE TO COMPLY MAY RESULT IN \$250 FINE PER OCCURRENCE!**
